COVID-19 symptoms are as follows:</p> <ul style="list-style-type: none"> <li>Primary symptoms of concern: cough, fever (<i>temperature</i> greater than 100.4°F) or chills, shortness of breath, or difficulty breathing.</li> <li>Note that muscle pain, headache, sore throat, new loss of taste or smell, diarrhea, nausea, vomiting, nasal congestion, and runny nose are also symptoms often associated with COVID-19. This can be done visually and/or with confirmation from a parent/caregiver/guardian. ### 1h. FACE COVERINGS, FACE SHIELDS, AND CLEAR PLASTIC BARRIERS
